With over ten years of experience in insurance regulation, life insurance pricing and valuation, and capital market investment, he plays a vital role in ensuring the solvency of both life and non-life insurance companies.

As an insurance regulator, he oversees the development of critical insurance regulations in Thailand, including the Risk-Based Capital (RBC) framework, Enterprise Risk Management (ERM)/Own Risk and Solvency Assessment (ORSA), asset and liability valuation standards, actuarial standards of practice, and professional development in Thailand. Chansak is renowned for pioneering practical guidelines for approving insurance capital bonds (IC bonds) as an alternative to strengthening insurance companies' capital.

Furthermore, he has been instrumental in driving transformative projects, such as optimizing surrender risk charges and enhancing foreign equity hedging strategies within the RBC framework.
