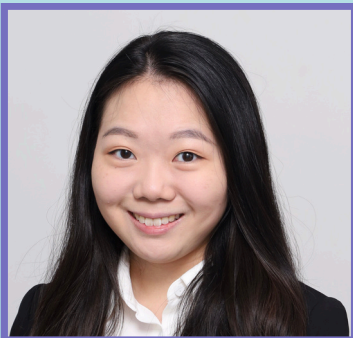


MR. JONATHAN SIMMONS
